<u>AUTHORIZED PETTY CASH FUNDS:</u> Supervisor \$300.00, Town Clerk \$100.00, Town Court \$150.00 and Tax Collector \$250.00 will all remain the same. A motion to approve was made by Councilman Peters, 2nd by Councilman Van Valin, with all in favor. (See Town Board Resolution #1 of 2020)

<u>HIGHWAY SUPERINTENDENT:</u> to authorize permission to purchase highway materials at State and County bid prices and use New York piggyback law when it is advantageous to the Town of Windham. A motion to approve was made by Councilman Van Valin, 2nd by Councilman Walker, with all in favor. (See Highway Fund Resolution #1 of 2020)

<u>TOWN BOARD MEETING NIGHTS:</u> Meetings will be on the 2nd and 4th Thursday of each month at 7:00 p.m., unless it conflicts with National Holidays, then an alternate date is to be selected. A motion to approve was made by Councilman Van Valin, 2nd by Councilman Peters, with all in favor.

<u>WAGE SCHEDULE:</u> The following rates were approved: **Temporary Clerical Help** will be at minimum wage of \$11.80 per hour (as of December 31, 2019) and **Clerical Help**-part time position-20 hours per week will be at a minimum wage of \$11.80 per hour. A motion to approve was made by Councilman Peters, 2nd by Councilman Walker, with all in favor. **Account Clerk/Clerk to Main Office (Bette Rhoades)** pay will increase from \$19.15 per hour to \$19.55 per hour as a full-time position-40 hours per week. A motion to approve was made by Councilman Peters, 2nd by Councilman Goettsche, with all in favor. The **Bookkeeper to the Supervisor (Cynthia Nelson)** pay will increase from \$21.30 per hour to \$21.75 per hour as a full-time position-40 hours per week. A motion to approve was made by Councilman Peters, 2nd by Councilman Van Valin, with all in favor. **Vacant Deputy Town Clerk** will remain the same as last year (2019) at \$15.50 per hour, at a starting pay should the position be filled again. A motion to approve the pay recommendation was made by Councilman Peters, 2nd by Councilman Van Valin, with all in favor.

Police Chief Tor Tryland (part time-20 hours per week) will increase from \$30,000 annual salary to \$31,000 annual salary. A motion to approve was made by Councilman Peters, 2nd by Councilman Goettsche, with all in favor. **Training Officer/**Creation of Policy (**Tor Tryland**), Councilman Peters would like to propose \$20.00 per hour with flexible hours. A motion to approve was made by Councilman Peters, 2nd by Councilman Van Valin, with all in favor. **Supervisor Hoyt stated the Police Union Contract salaries will be noted for the Police Officers hourly rate. The Police wages are calculated according to the Union Contract. Full time police officer per union contract for 2019 is \$21.48 per hour and Part-time police officers per union contract for 2019 is \$17.99 per hour. Police Recruit part time minimum wage \$11.80 per hour for 2020.**

Highway employees **Troy Alpin, Michael Mattice, Edwin Ohl, Mark Smith and Scott Schoonmaker** for MEO are paid \$21.30 per hour for each man as a full-time position and **Devin Drum** (General/Highway) is paid \$14.30 per hour. The **Highway Dept. Labor/Wingman/Sidewalk Maintenance** are paid \$14.30 per hour for a part time-20 hours per week position as needed to be done by **Tyler Hoyt & John MacDonald. Supervisor Hoyt per the Taylor Law; the highway employees raise per hour are frozen until we get a contract from the Union which they are currently under negotiations with. The current noted above employee rate for the highway stands the same.**

Board of Assessment Review Members will remain at \$80.00 per session. **Planning Board Members** will remain at \$25.00 per session. **Planning Board Chairman** will remain at \$50.00 per session. **Planning Board Recording Secretary** will remain at \$40.00 per session. A motion to approve the above was made by Councilman Peters, 2nd by Councilman Van Valin, with all in favor.

CD Lane Park Laborer -part time -20 hours per week minimum wage \$11.80 per hour. **John Wolf** (Park part-time seasonal help) pay will increase from \$12.50 per hour to \$12.75 per hour. A motion to approve was made by Councilman Peters, 2nd by Councilman Walker, with all in favor. **Court Clerk (Jessica Braden)** will increase from \$14.55 per hour to \$14.75 per hour as a part-time position-20 hours per week. A motion to approve was made by Councilman Walker, 2nd by Councilman Peters, with all in favor.

The **Sole Assessor** (**Richard Tollner**) is the newly appointed Assessor; his 6-year term is effective 10/01/19 and will expire on 09/30/25. His pay is currently at \$23.30 per hour will increase to \$23.75 per hour as a full-time position-40 hours per week. A motion to approve was made by Councilman Peters, 2nd by Councilman Van Valin, with all in favor. **Code Enforcement Officer/Building Inspector (Dominick Caropreso)** pay will remain the same \$29,000 annual salary based on three (3) full working days, with no mileage reimbursement. A motion to approve was made by Councilman Peters, 2nd by Councilman Walker, with all in favor. Water Superintendent Kyle Schwarz will increase from \$22,000

annual salary to \$25,000 annual salary. A motion to approve was made by Councilman Peters, 2^{nd} by Van Valin, with all in favor.

Ambulance Driver on Call will remain at \$36.00. Ambulance Driver per Hour will increase from \$13.25 per hour to \$13.50 per hour. EMT on Call will remain at \$46.00. EMT per Hour will increase from \$16.00 per hour to \$16.35 per hour. AEMT- Intermediate on Call will **AEMT- Intermediate per Hour** will increase from \$18.00 per hour to remain at \$46.00. \$18.35 per hour. Paramedic on Call will remain at \$56.00. Paramedic per Hour will increase from \$20.75 per hour to \$21.75 per hour. A motion to approve was made by Councilman Peters, 2nd by Councilman Goettsche, with all in favor. **Ambulance Administrator Davia Montie was re-appointed**. A motion to approve was made by Councilman Peters, 2nd by Councilman Walker, with all in favor. Ambulance Administrator will increase from \$24.00 per hour to \$25.00 per hour as a part time position-20 hours per week. A motion to approve was made by Councilman Peters, 2nd by Councilman Walker, with all in favor. Christopher Maurer as Quality Improvement Coordinator (position created 1/01/18) to assist Ambulance Administrator Davia Montie. His pay will be \$1,000 stipend at the end of the year. A motion to approve stipend to stay the same was made by Councilman Peters, 2nd by Councilman Walker, with all in favor.

<u>GREENE COUNTY EMS REPRESENTATIVE</u>: Supervisor Hoyt would like to recommend Councilman Peters be appointed. A motion to approve was made by Councilman Walker, 2nd by Councilman Van Valin, with all in favor.

<u>SEWER DISTRICT-GREASE TRAP INSPECTOR:</u> (position created 01/2013) Supervisor Hoyt recommends Josh Vital to be re-appointed. A motion to approve was made by Councilman Peters, 2nd by Councilman Van Valin, with all in favor.

<u>EOC COORDINATOR</u>: (position created 01/2013) Supervisor Hoyt (The primary EOC is to be at the WWTP with the Town Hall as the secondary location)

<u>EOC COMMITTEE</u>: (created 01/05/2015) Supervisor Hoyt and the Town Board Councilmen Van Valin, Walker, Peters and Goettsche only to be on this committee. A motion to accept was made by Councilman Peters, 2nd by Councilman Walker, with all in favor. This Committee will make recommendations on how to handle emergency situations in the town.

<u>SWAC COMMITTEE:</u> Primary Councilman Walker and Secondary Councilman Van Valin were re-appointed. This is a two-year term limit. The term will expire December 31, 2020.

2.LIST OF PLANNING BOARD MEMBERS were made available for the Board's review. David Weiman would like to remain in as the Planning Board Chairman. His new term as the Chairman will expire December 31, 2020. A motion to re-appoint David Weiman was made by Councilman Walker, 2nd by Councilman Peters, with all in favor. John Garzone's term has expired December 31, 2019. The Town Clerk will write a thank you note to John for his years of service. Sandra Allen will remain the recording secretary and will be an alternate member as needed. The current board members/terms are as follows: **Thomas Poelker** term expires December 31, 2020; **Edward Shanley** term expires December 31, 2022; **Lisa Jaeger** term expires December 31, 2023; **David Weiman** term (excluding Chairman) expires December 31, 2024 and **Claudia Lane** term expires December 31, 2025. <u>ARCHITECTURAL REVIEW BOARD MEMBERS</u> are the same named members/terms as above for the Planning Board members.

<u>3.LIST OF LIBRARY TRUSTEES</u> was made available for the Board's review. The terms for Margaret Mulford, President and Peter Peters have expired on December 31, 2019. The Library Trustees in a letter made a recommendation to **re-appoint both Margaret Mulford and Peter Peters for a five-year term.** A motion to re-appoint Margaret Mulford was made by Councilman Peters, 2nd by Councilman Walker, with all in favor. A motion to approve Peter

Peters was made by Councilman Walker, 2nd by Councilman Goettsche, with 4 in favor, Councilman Peters has to abstain. Their new terms will expire December 31, 2024.
