<u>5.WATER DISTRICT RESOLUTION #7 OF 2022:</u> whereas the group of 80 properties in the Town of Windham Water District are delinquent in water payments; and these properties are delinquent in the amount of \$44,811.97. Now therefore be it resolved that these amounts are to be included in the Tax Rolls as a charge against the real properties concerned.
