- A. Upon the filing of an application for a building permit the following fees shall be payable:
 - Single Family House, including shells and prefabricated construction Under 2,000 Square Feet- \$250.00 Over 2,000 square feet- \$1.00 per square foot
 - Mobile Home, including support system Single Wide-\$100.00
 Double Wide on a slab-\$150.00
 - 3. Additions, alterations, garages, storage buildings and other construction (non-commercial)
 Under 500 Square Feet- \$0.50 per square foot
 Over 500 Square Feet- \$1.00 per square foot
 - 4. Non-residential farm building, including barns, sheds and poultry houses, used directly and solely for agricultural purposes- \$50.00
 - 5. Commercial Buildings- \$1.00 per square foot of gross floor space
 - 6. Operating Permit- \$100.00
 - 7. Fire Safety and Property Maintenance Inspections- \$100.00
 - 8. Demo Permit- \$150.00
 - 9. Roof Replacement- \$100.00
 - 10. Above Ground Pool- \$150.00
 - 11. Temporary Tent- \$200.00
 - 12. Install of Stove/Fireplace/Generator-\$150.00
- B. In the event that an application for a permit is not approved, the applicant shall be entitled to a refund of 50% of the fee paid, provided no work has been commenced. If work has been started and application is NOT approved, fees paid shall NOT be refunded.

As prescribed in part 444.3 (c) of the Uniform Code of the State of New York no occupancy or use of the premises covered under this permit shall be allowed without first obtaining a Certificate of Occupancy or Certificate or Compliance.

A Certificate of Approval must be obtained from the New York State Board of Fire Underwriters for the electrical work performed.

Amendments, if any, to the application or to the plans and specifications accompanying the same shall be filed with the building official and approval received from the enforcement official prior to the commencement of such change of work.

Three (3) copies of plans showing proposed construction including complete specifications and three (3) copies of the plot plan drawn to scale showing actual dimensions of the lot to be built upon, the location of the proposed construction, and the location of the driveway reaching the construction, specifying road frontage from each side of the driveway to the adjoining lots.

Drawings certified and sealed by a New York State Licensed architect or engineer as prescribed by section 7307 or 7209, as amended, of Article 147 or 145 of the Education Law, State of New York, will be required if one of the following conditions for construction exists:

- residential construction greater than 1500 square feet in floor space;
- the construction is other than residential construction;
- renovations, additions, replacements or any other work connected to an existing structure is estimated to have a value of over \$20,000;
- any work which requires a "structural" change to an existing structure;
- part 444.3 Uniform Code: Minimum Standards for Administration and Enforcement.

The application and drawings submitted shall be signed by the owner of the property or building or work, and acknowledged by a Notary Public that said drawings and application being submitted are the drawings and application intended for submittal for a Building Permit.

The application is to be received at least two (2) weeks prior to starting work, during which a permit will be issued or denied.

The applicant state he/she has read the Building Code of Ordinance and application requirements and furthermore agrees that all work performed shall be in compliance with the State Uniform Fire Prevention and Building Code and applicable state and Local Laws, Ordinances and Regulations.
